OFFICIAL RULES

1. NO PURCHASE OR PAYMENT NECESSARY TO ENTER. A purchase does not improve your chance to win. Void where prohibited.

2. AM I ELIGIBLE? Open only to legal residents of the fifty (50) United States and the District of Columbia, 18 years of age or older as of their date of entry. Employees of Cintas, their affiliates, subsidiaries, participating retailers, advertising and promotion agencies, web site providers and the immediate family members (parents, siblings, children) and/or those living in the same household of each are not eligible to win.
